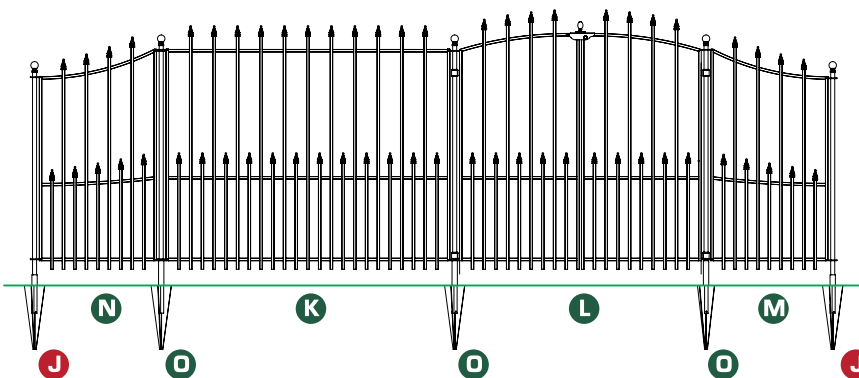

DecorativeFence INSTALL GUIDELINES

- DecorativeFence is intended for installation on level ground.
- Rocks may need to be removed before driving stakes.
- Determine starting point, usually gate position, corner or fence center.
- Care should be taken so Stakes and Posts are as plumb as possible.
- One Post & Stake needed per panel plus one additional to end each run.

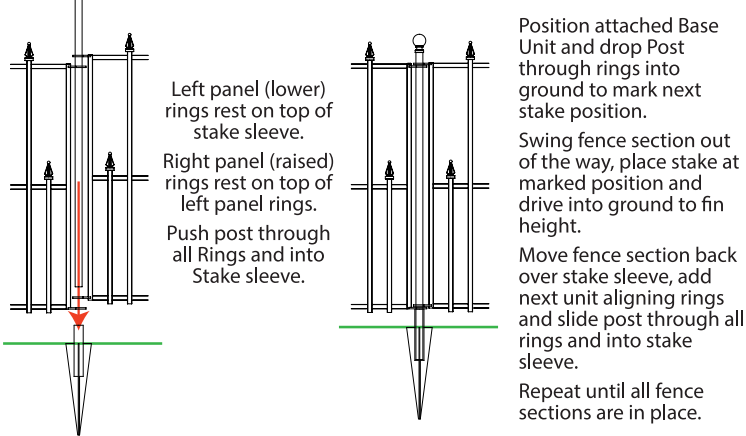


GATE LATCH

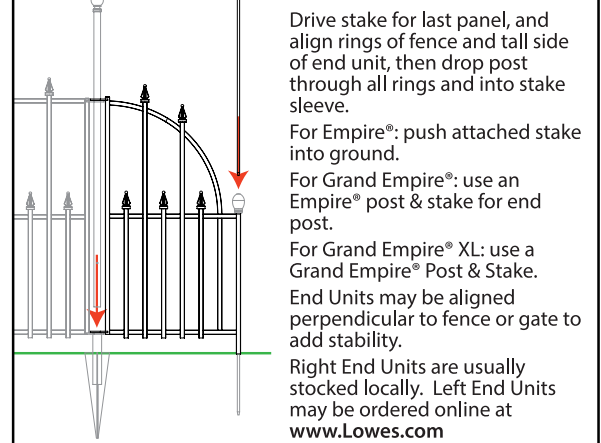

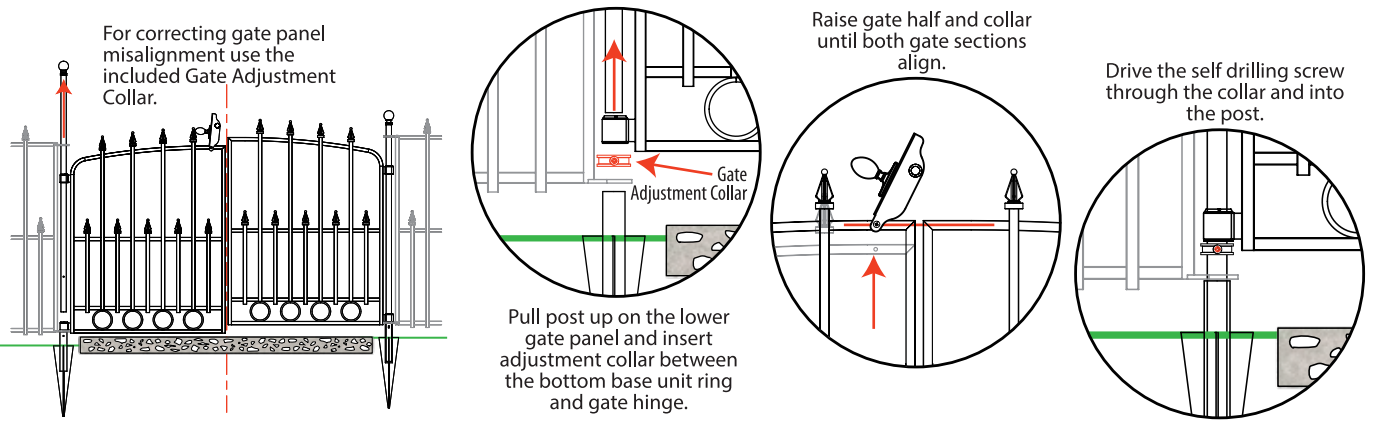
INSTALL BASE UNITS

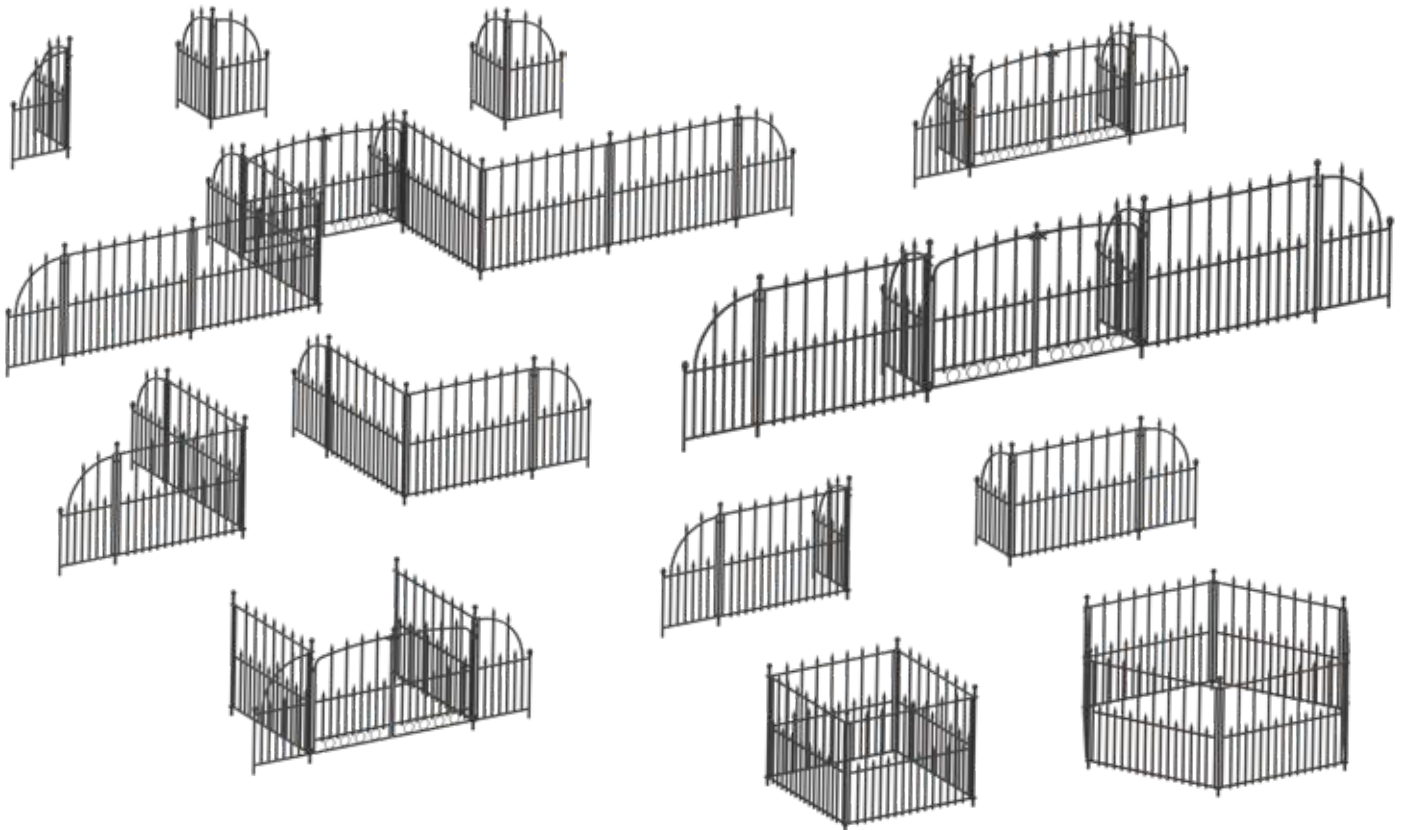


INSTALL END UNITS

Origin Point Brands® also warrants that the fence will be free from defects in workmanship and materials for a period of five (5) years. This warranty is extended only to an original purchaser who installed the product at a residence (not commercial premises) in the 50 United States. It is not transferable.

If a defect exists, Origin Point Brands® will, at its option, either repair or replace the product or the defective component. This warranty does **not** cover the costs of labor to remove a defective product or component or install any replacement product or component.

This warranty shall **not** apply to defects or damages caused by mishandling, improper installation or installation not in accordance with the instructions provided with the product, alteration, removal or re-installation, improper or unreasonable use, maintenance or storage, use of incompatible accessories, accident, impact by foreign objects, fire, acts of God or normal wear and tear.
